#### **Brief Synopsis**

An introduction for project management professionals providing an engaging introduction to the core concepts and principles of NLP (Neuro Linguistic Programming) in the context of project management. After establishing the role of behavioural competences across the life-cycle and components of projects, the pillars and core components of NLP will be taught through practical exercises. NLP tools and techniques will then be demonstrated against key competences required for effective project management, for example as described in competency frameworks for higher levels of certification by professional bodies, through practical examples, tools and techniques.

### Learn about:

- understand how soft skills support all components and processes across each stage of the project life-cycle;
- assess their own behaviours and preferences using standard frameworks including language and behaviour profiling;
- know which phases and components of project management are best performed with which behaviour styles and understand where they may have gaps;
- understand the basics of NLP and how it can be applied to project management;
- know how to identify different stakeholder maps of the world and how to bridge the divide through effective communication methods;
- start to develop flexibility in key behaviours using standard NLP techniques;
- conduct practical exercises on key project activities such as team-based planning.
