### **RE: EXEMPTION FROM PAYMENT OF ANNUAL SUBSCRIPTION PURSUANT TO RULE 8.2**

Pursuant to Rule 8.2 of the Rules of the Institute (reproduced below), members who have attained the age of 65 years or more (whom have been a member for five years and above) shall be eligible for exemption of annual subscriptions. For members who wish to be exempted under the said Rule 8.2, please complete the form attached below and submit the same to the Institute, together with a **copy of your NRIC or passport. If you have submitted the form earlier, kindly disregard this notice.**

Rule 8.2 states:

*A member who has attained the age of sixty-five (65) years or more shall be exempted from payment of annual subscriptions provided that he/she had not been struck off/ removed from the register of members and for five (5) years immediately preceding such exemption he/she had been a member in good standing and had fully paid up all dues to the Institute. This provision is not applicable to Corporate Members.*
