Wei Mun has appeared in all levels of the Malaysian Court system where close to 30 cases which he has argued have been reported and published.

Wei Mun is a member of the panel of arbitrators of the International Chamber of Commerce, Malaysia, Kuala Lumpur Regional Centre for Arbitration, and Korean Commercial Arbitration Board. He is a Fellow of the Chartered Institute of Arbitrators, Malaysian Institute of Arbitrators and Singapore Institute of Arbitrators.
