### **SYNOPSIS**

The use of ADR mechanisms to resolve construction disputes is not alien to the construction industry. The most popular ADR mechanism used in the construction industry is Arbitration. Besides the use of Arbitration there are other ADR mechanisms like Adjudication, Mediation /Conciliation. Mediation is internationally regarded as a very cost-effective and efficient means of resolving construction disputes, reducing the risks of costly conflict and delay. This seminar will provide participants with a comprehensive insight into its usage, along with options as to how best to use it.

The seminar will touch on various ADR mechanisms and in particular mediation and explain the process and how the mediator who acts as a catalyst to the mediation process assists parties in the resolution of their disputes. The mediator defines the issues, opens up channels of communication, explores options and alternatives and facilitates negotiation between the parties towards reaching a settlement using mediation techniques. Mediators do not talk about legal entitlements but about "interests". Mediators look to capture a solution that parties could live with, rather than identify rights and duties. Mediation is a party empowered process and parties are the decision makers. The remedies available in mediation are far wider than what can be achieved in Arbitration or Adjudication. More importantly it preserves and maintains harmony in the relationship between the parties involved in the construction dispute. The progress and current trends of mediation in Malaysia in the construction industry will also be covered in this seminar.

She has been an active committee member of the Alternative Dispute Resolution Committee of the Bar Council, Malaysia since its inception in 1999. She took charge in drafting the "Mediation Rules", the mediators "Code of Conduct" of the Malaysian Mediation Center and the guidelines for accreditation of mediators onto the panel of the Malaysian Mediation Center of the Bar Council. She was also responsible for drafting the draft "Mediation Act" on behalf of the Bar Council and was involved with deliberations on the said Act with the Attorney General's office.
