This intensive course in **International Commercial Arbitration** is offered over 9 days - 7 days in Kuala Lumpur and 2 days in Malacca. Participants will be taught the practice of international commercial arbitration, including all major forms of arbitration and related dispute settling mechanisms such as WIPO and CIETAC. Participants will gain the ability to appear in or act as an arbitrator in such arbitrations in different contexts.

The course assumes a knowledge of law either from a law faculty or some other discipline, such as economics. Successful completion of this programme may enable students to gain advanced standing in postgraduate programmes offered by the Faculty of Law at the University of New South Wales.

The course covers the fundamentals of international commercial arbitration. The lectures and workshops analyse legal concepts and issues arising during the course of an arbitration.

The course offers specialised study in **Investment Treaty Arbitration, WIPO Arbitration and Construction Arbitration**. In the weekday afternoon sessions, participants take part in practical group workshops, under the guidance of experienced arbitrators. Students will be given practical training in the conduct of an international arbitration and will discuss a range of problems which may arise in the course of conducting an international arbitration.

There is a course dinner for students, speakers and panellists in Malacca on **Saturday, 14th April 2012**.

- What is international commercial arbitration?
- What laws, legal norms and legal systems apply in International Commercial Arbitration
- The History and Development of the framework of the New York Convention, the UNCITRAL Model Law and the laws governing International Arbitration in Australia and Asia
- The Arbitration Agreement: formation validity activation and scope, how to draft an appropriate arbitration agreement
- Anti-suit Injunctions and Stays
- The appointment of the arbitrator
- The Arbitrator's independence and impartiality
- Confidentiality in arbitration
- Interim Measures
- The Hearing
- The Award; Interest and Costs, and Award writing skills
- Recognition and enforcement of arbitral awards
- Investment Treaty Arbitration
- An examination of the CIETAC Arbitral Process
- WIPO Arbitration procedures
- Construction Arbitration
