About the Speakers

Tan Sri Dato' Cecil Abraham, Senior Partner with Zul Rafique & Partners, is a Barrister-At-Law of the Middle Temple and is a Bencher of the Inn. He is a graduate of Queen Mary College, University of London. He is a Chartered Arbitrator and a Fellow of the Chartered Institute of Arbitrators U.K., Malaysian Institute of Arbitrators, Singapore Institute of Arbitrators and the Australian Centre for International Commercial Arbitration Limited. He has been involved as Arbitrator and Counsel in more than 100 arbitrations under the ICC, SIAC, KLRCA, LCIA and ICSID Rules and also in Ad Hoc arbitrations. He is a Member of the ICSID panel. He has represented the Government of Malaysia in an ICSID arbitration and is presently involved in annulment proceedings under the ICSID Convention. He is also a Member of the Permanent Court of Arbitration. He was a former Member of the LCIA Court.

Mr Sundra Rajoo is the Director of the Kuala Lumpur Regional Centre for Arbitration (KLRCA). He is also the President of the Asia Pacific Regional Arbitration Group (APRAG), which is a federation of nearly 40 arbitral institutions in the Asia Pacific region. Sundra is a Chartered Arbitrator and an Advocate & Solicitor of the High Court of Malaya (non-practising). He is also a Professional Architect and Registered Town Planner. He has had over 180 appointments as arbitrator either as chairman, co-arbitrator of three-man panels and sole arbitrator in international and domestic arbitrations.



He serves on the panel of numerous international arbitral institutions and organisations, including the Chartered Institute of Arbitrators (UK), Singapore International Arbitration Centre (SIAC); Australian Centre for International Commercial Arbitration (ACICA), Cairo Regional Centre for International Commercial Arbitration, the Indian Council of Arbitration, Hong Kong International Arbitration Centre (HKIAC), Korean Commercial Arbitration Board (KCAB) and Chinese International Economic Trade and Arbitration Commission (CIETAC). Sundra has also authored several books on arbitration and contract law, including, "Law, Practice and Procedure of Arbitration" (2003); "The Malaysian Standard Form of Building Contract (The PAM 1998 Form)" (1999); and the Arbitration title for Halsbury's Laws of Malaysia (2002). He was also the co-author of "The Arbitration Act 2005 – UNCITRAL Model Law as Applied in Malaysia" (2007) and "The PAM 2006 Standard Form of Building Contract" (2010).

Yang Amat Berbahagia Tun Dato' Seri Zaki bin Tun Azmi is a former Chief Justice of Malaysia and the Chairman of the ASEAN Law Association (Malaysia). He had his early education in Malaysia before obtaining a Barrister-at-Law from Lincoln's Inn in 1969. He joined the Malaysian Judicial and Legal Services as a Magistrate and then went on to serve in the Attorney-General's Chambers where he held several positions for 15 years before going into private practice. While in practice, he sat on several public listed companies as a director as well as chairman or member of their Board Audit Committees. These companies included Petronas, the national oil company, Malaysia Airports Berhad and SP Setia Sdn Bhd.



In 2007, Tun Zaki was appointed as a Federal Court Judge before becoming the President of Court of Appeal, the second highest judicial office, a few months later. He was appointed the 12th Chief Justice of Malaysia in October 2008 before retiring in October 2011. During his period as Chief Justice of Malaysia, Tun Zaki substantially reduced the backlog of cases pending at the Malaysian courts as well as introduced technological and managerial systems that enabled cases at the High Court to be disposed of within nine months to one year from the date of filing and within six months at the Sessions and Magistrate's courts.

Mr Lim Chee Wee graduated from the University of New South Wales, Australia with a LLB degree and B. Comm. (Accounting) degree, and was admitted to the Malaysian Bar as an Advocate & Solicitor in the High Court of Malaya in March 1993. He started practising in SKRINE and was made a partner in January 2001. Throughout his years of practice, Mr Lim has played an active role in the Bar. He was made the Chairman of Kuala Lumpur Bar Committee from 2005-2007 and was elected as the Honorary Secretary of the Malaysian Bar in 2007-2009 and later, as Vice President of the Malaysian Bar in 2009-2011. Currently, he holds the position as the President of the Malaysian Bar for 2011/2012 and 2012/2013. Mr Lim has experience in commercial and corporate disputes in Asia and Europe; and he has regularly advised and acted as Council for the Malaysian Stock Exchange.
